Meeting called to order at 10:30 AM.

Draft Meeting Minutes from May 10, 2018 approved with minor revisions. <u>MOTION</u> offered by Suzanne, second by Bill. ALL in favor - unanimous

Elections:

Ray noted that our Bylaws need to be updated to incorporate the new procedure we follow regarding elections. A comparison of the old section on elections and a revised section was presented. There are some other sections of the By-laws that need to be brought in line with the changes to NY State Non-profit Corporation law. Ultimately the Key-holders would need to vote on the changes to the By-laws. Ray will work on this in consultation with our lawyers to make sure all provisions of the By-laws are in order before presenting the revisions to the Key-holders for a vote.

As per our By-laws, a nominating committee must be appointed no later than July. An announcement regarding nominations will be placed in the August *Trail Marker* and the list of candidates will be placed in the October *Trail Marker*. Candidates will be able to post a statement about themselves in the October *Tail Marker*. A Tallying Committee will also be formed.

The AMC Invitational only included current key holders, most of whom were also AMC members. The suggestion was made to skip this invitational for next year.
