Excerpts of Some Reports from the Special Open Meeting for All New York Chapter Members Held September 14, 2019

[The yearly gathering of New York Chapter members provides an opportunity for all to receive updates on the status of the Chapter, the workings of the Board and all committees, and current projects in development. Thirty-two members showed up for this special year's meeting. Below are some excerpts of reports from the meeting. The full minutes of the meeting and all reports will be posted on our website.]

Treasurer's Report -Suzanne Rocheleau

Year In Review -2018 - 2019 Camp Season

<u>Financials</u>. The last two years of Financials (P&L and Balance Sheet) as well as the most recent Vanguard Wellington Income Fund statement have been provided for member review. Overall, the Chapter's Vanguard Wellington Income and Money Market Funds have been performing very well. For the year ending 2018, the Income Fund earned \$2,839 in capital gains distributions and \$2,650 in dividends.

<u>Donations</u>. The NY Chapter received generous donations from three benefactors which will help offset the cost of maintaining camp. This will cover any general necessary repairs to camp including unexpected required emergency repairs that may arise.

LRS Filing. Form 990n was filed electronically with the IRS to maintain our 501c7 tax exempt non-profit status with the IRS. This is an annual filing requirement.

<u>Insurance</u>, <u>Rent.</u>.Our Chapter insurance expenses for the year were as follows:

\$1,104 for Director's & Officer's coverage and \$8,799 for Liability coverage. The NY Chapter's rent expense payable to PIPC was \$6449 and we signed our lease with PIPC that extends for 10 years.

<u>Legal Advising.</u> Per NY non-profit law, between 2017 – 2018, the NY Chapter paid \$1,811 in legal fees to John Caffrey and his team for legal advising. In 2019, \$1,000 in fees were paid to Marvin & Co for accounting, audit fees and a review of our books. Going forward the Board has agreed to have an audit every other year.

Conservation Committee Report - Don Gabel, Chair

The last ADKNY Conservation Committee project by Don Gabel, Chair, was to plant about 50 resistant hemlock seedlings sourced from and developed by scientists at Rhode Island University. Don visited the planting site in Harriman late August. Three of the hemlocks have succumbed probably due to lack of water. The remaining trees are thriving. Don will continue to monitor this grove of hemlocks with his crew and send updates to the URI, as well as the NYS Hemlock Initiative. Just a note: The NYS Hemlock Initiative, a state-wide cooperative conservation effort including Cornell University, interviewed Don for their "Hemlock Tribune" blog. They highlighted his efforts to help save the Hemlocks in NYS. Don made sure to give credit to his volunteers, which included members of the ADKNY.

Notes from Palisade Camp Association Meeting

Attended by Teri Gabel, New York Chapter Board Vice-Chair, on July 31, 2019

- AMC is proceeding with restoration projects using volunteer days. They are continuing to work
 on funding. Volunteers and members (AMC) may email jfurguson@outdoors.org to participate.
 [Note: It has been reported that AMC has been given a three-year lease for Baker Camp.]
- A composting email disseminated to some camp directors is a NYS effort, not a Park effort.
- The Park is looking into complaints about beaver activity at several lakes.
- A recycling company, Sterling, is being used by 1 or 2 camps. The \$450/yr. fee is shared with the Park. However, most programs initiated at other camps, including the ACA, have not been successful. The predominant reason is bear activity. People don't rinse and dumpster cleanliness is not maintained, the bears rip the dumpsters apart.
- The Nature Museums celebrated 100 years this summer.
- There was a discussion about ambulance access and responses. All camps need to make sure of
 which company to call for service. Each address in Harriman goes to different ambulance
 companies, and the Park Police (whose personnel answering the phone changes frequently)
 don't always call the correct ambulance.
- Campers were reminded that we need to take precautions from bears, such as cleaning outdoor grills with ammonia. (Don has been asking, when he is in the kitchen, that all recyclables be rinsed before recycling).
- There is a crew of four carpenters that work for the Bear Mountain Regional Maintenance, and camps are encouraged to forward requests to them through Tony Dilaro and Robert Kuhn. Several camps added that they received better responses for significant projects such as new roofs, by going either directly to Jim Hall, or contacting these two.
- Camp K-20 (old Masonic Camp of Haverstraw) celebrated 100 years in 2019. They opened a new café during the summer to PCA members only. Call 845-942-0897 for information. – Teri Gabel

Notes from the Secretary's Report

Website

The Board has appointed Brandon Hunt as the new web master. Brandon has been working diligently on building the site. The platform being used is Squarespace. It will be very much similar in design to the original web site but with a fresh, updated look. It is also intended to be more user friendly.

A suggestion was made to introduce a link for a chat group for Nawkawans to coordinate directly with one another to arrange to meet and to coordinate transportation opportunities. This suggestion will be added to the site. Any additional suggestions should be forwarded in writing to Board Chair, Lisa North for placement on the Board agenda for discussion.

Brandon is continuing to both transfer some of the existing material from the old site to the new site as well as post new, current information. When the Board reviews the web site it will be made public. We are planning for the web site to be live on or about October 1, 2019.

Any new materials that the membership would like to have posted should be sent to the Board Chair, Lisa North or to the Editor Ray Kozma. They will review the material for accuracy and content prior to submitting it to Brandon for posting to the site.

Explanation of the change to the Certificate of Incorporation

Specifically - The Certificate of incorporation currently says there will be 9 Directors. The current Bylaws state there may be 10 or 11 Directors. Thus, to resolve this inconsistency in the number of Directors, the proposed amendment to the Certificate of Incorporation will remove the sentence that calls for a specific number of Directors.

Lisa read a portion of the 1931 Certificate of Incorporation to demonstrate the goals expressed at that time continue to remain relevant for us today.

<u>Motion -</u> motion offered to accept the Amendment to the Certificate of Incorporation to remove 1 sentence which noted 9 directors. Motion offered by Marty Kellerman, second by Teri Gabel. Vote in favor - unanimous.

Porch Railings Report- Guy Lingley -Director

There is a need to replace the wood rails on the porch. They are still serviceable but meeting the end of their useful life. The building code requires a 42 inch height rail. The goal in determining the new design of the railing system was to provide the minimum necessary as not to change rustic character and not to block views. Guy researched different companies. Saugerties NY company will perform turnkey operation and replace horizontal rails with unpeeled pine members. Acawoods, Minn. Company is another company that was researched. The code also requires a maximum post spacing of 4 inches.

Thus an infill material is needed. Wood infill was too intrusive and blocked views. As a result, the Board opted for infill metal frame with mesh. Ponderosa Pine or Eastern red cedar were suggested materials. Cedar has taper. 3 to 5 inches thus would be more intrusive. The rails would have a square cut. The pulley system was addressed.

The stair rails need a bit more work. It is proposed to add a speed rail system onto the existing dimensional lumber to provide a code compliant handrail and to add additional vertical posts. The stairs will also require an in fill mesh as fall protection with a maximum 4 inch gap. The same methodology as incorporated on the porch rail will be utilized for the stair rail.

Camp Chair Report- Don Gabel, Chair

Don stressed the need for all members to contribute towards the maintenance of camp. There are many different types of jobs available for varying levels of skill, ability and endurance.

The fallen tree removal was a major issue with the swim dock being temporarily closed for a short time. Many people pitched in to help. A special thanks was made to Ray Lustig who was instrumental in removing the submerged tree branches alongside the swim dock. He was determined to get the job completed with repeated dives to cut the underwater branches despite the cold water.

Don outlined some of the various projects that need to be completed and again stressed the need for volunteers. The project list includes but is not limited to: The skirt around perimeter of lodge needs repair/replacement, the rails to the steps need to be added. Due to the age of the facilities much maintenance is continually needed, and the work is not getting completed. All members must help.

Members need to be reminded that trash and recyclables must be removed from the lodge. Ants were becoming an issue due to the lack of proper sweeping and clean up. Recyclables must be rinsed clean.

Further Comments and Discussion Topics

Guest policy

Discussion followed regarding the number of guests a member may bring at one time. Various opinions were offered. The goal is to introduce new people and potential new members to camp thus many agreed an increase in the number of guests was acceptable. It has become apparent that new members

are needed to assist in the maintenance of the infrastructure and facility and to ensure the long term viability of Camp Nawakwa. Flexibility and common sense should prevail. For instance, if a potential guest is a family of 5, it would make sense to allow the entire family of 5 to visit.

Large groups should continue to be handled as an Invitational as per the current regulations.

Everyone agreed it is solely up to the member to supervise their guest. Any infraction or abuse of the flexible system should be noted immediately, and that member warned. Sanctions may be imposed upon a specific member: i.e. - lose privilege of having guests. The Board is taking. all these comments and suggestions under advisement.

Do You Know Any Member Who Is Not Receiving the Trail Marker?

At a recent hosted weekend at Nawakwa, a problem with the email delivery of the Trail Marker was the big topic of discussion at the dinner table. We will be working with the Adirondack Mountain Club (Main Chapter) to resolve the issue. [Note: First make sure the email did not go to your spam folder.]

The mailing list used to distribute the Trail Marker is provided by the Main Chapter. It is based on the information they have for all current members of the New York Chapter. For Director (2 year term): Guy Lingley




For Director (2 Year Term): Diane Booth

- A. The undersigned Keyholder member of the New York Chapter, Inc. of the Adirondack Mountain Club, Inc. hereby authorizes (<u>if "yes" is checked below</u>), Eve Mancuso, the Secretary of the Corporation, to act as his or her proxy to vote for the amendment to the Certificate of Incorporation.
- B. Explanation: The amendment to the Certificate of Incorporation is the removal of a sentence that sets the number of directors at 9. The reason it is being changed is that previously both the Bylaws and Certificate of Incorporation set forth how many directors there should be, but they didn't match. The Chapter was following requirements of the Bylaws, which states that there should be 10 or 11 directors. Because the two governing documents contradicted each other, one needed to be changed. It was decided that it should be the Certificate of Incorporation that is changed, because (1) the Chapter was already following the Bylaws, (2) the Certificate of Incorporation is not required to state the number of directors, and (3) the Bylaws are easier to amend than the Certificate of Incorporation, so it will be easier for the Chapter to change the number of directors in the future if needed.
- C. This Amendment will be voted upon first by the Board of Directors and if approved forwarded to the Keyholder membership for a vote. If the Keyholder membership votes in the affirmative, the Certificate of Incorporation will be officially amended upon filing with the State.

From the Archives - Ellen King

Frank Place 26 Clinton Avenue Cortland, N. Y.

Feb.27,1955

Dear Walter:

The I was invited by another member of the Adk to the relocation of the R-D trail I feel like writing to you as well. I had to decline the invitation, the I would like to see you all and the new location. But my legs can not take it, and I dare not try any severe walking.

It is with great regret that I cannot be present at a rededication of the Ramapo-Dunderberg Trail on which I have spent many days in the past. I well remember the days of the forming of the Palisades Interstate Park Trails Conference at the invitation of Major Welch, manager of the Park. He outlined to representatives of the walking clubs his idea of a system of trails throughout the Park and inspired us with the vision and our enthusiasm grew as we went on with the work. I count the days spent scouting, routing, marking and clearing trail as amon the happiest experiences I have had. My labors were on sections of the longer trails, R-D, T-MI, FB-SK, S-BM, and on most of the Crown Ridge, Kakiat, Lichen Trails and I often now think of occurrences on them that I'll not easily forget. Among them was the discovery of the 6-foot pot-hole on R-D near S-SB; the Half-and Half Boulder near Torne Fond, below Crown Ridge, to name two. Oneother boulder, triangular and perched on its apex,-I'll not reveal its location if it has not been found!

Trail work of any variety is soul-satisfying. One learns much. The result is useful to so many of the like-minded, and the path onelays down may be as long lived as any other work of man. All worries and stresses are forgotten while one is making trail. The soul is refreshed and pne feels nearer to nature than in almost any other way. At least that is my experience.

Of course when the Ramapo-Dunderberg was laid out the Adk had not been born. The copper squares have been replaced by larger ones, and the path is pretty well worn. But as a charter member of the Adk I take pride in remembering that it was my contribution"The Creed" that was adopted by the club. Little then did the members think of the problems of the Adirondacks that are now confronting them, but I think the Creed is valid after the three decades.

Convey to all present my best wishes for continued success of the club.

And still "I believe in the Out of Doors..."
