Camp chair will examine and retire boats that are not able to be repaired.

Tool assessment – this weekend Dave and Carl Jackman will review tools, determine what can be fixed, or be sharpened or disposed of.

Bill Hladky has been organizing the workbench. Donated the proceeds from scrap metals back to camp.

Main cabin repairs. Looking for material for cabin façade- raw wood from sawmill. First cut, or slab cut. New boards are needed. Dave and Jess found a source.

Cabin 1 and Cabin 6 roofs are leaking. Areas are marked in chalk. Roofs are near to the end of their lives. Dave will see if he can make a temporary repair but most likely would need to be replaced. Plan for replacement. May temporarily place tarps are the roof for over the winter to protect the structure.

Path Construction – difficult to get contractors to work in the park. Recommends focusing on other projects rather than the stone steps. Handrails were again discussed.
