Rent – though a 25% reduction is available for park approved expenses = 1064 reduction Directors and Officers Insurance \$ 1005, Liability Insurance \$ 9832, Rent \$ 4014, refrigerator \$ 1000.

Income: Camp fees \$ 4987, passport \$ 7800, annual fees \$ 8000, annual appeal donations \$ 4205.

Bequest from Helda Feder – \$ 20, 250, of that amount \$ 15,00 was invested in a CD at 4.35% for 1 year term with the remaining balance of the bequest going to the checking account.
